## Proposal 3 on the Ballot Is: Sterilization and Sexual Mutilation of Children

If approved by voters, the "individual right to reproductive freedom," which expressly includes "sterilization" and "infertility," and is not limited to adults, would allow **children** to be **permanently sexually mutilated** – without their parents' knowledge or consent.

Children "exploring their sexual identity" could be given vasectomies, mastectomies, puberty blockers, and more – without their parents' knowledge and even over their objections. This child sexual abuse would be enshrined in our Constitution.

## Abortion and Murder

If approved by voters, *all* forms of abortion - including **late-term abortion** up to the moment of birth, and **dismemberment abortion**, in which a baby is simply ripped out of his or her mother's womb limb from limb - would be legal, up to the moment of birth.

To fool voters, Proposal 3 says the state may regulate abortion "after fetal viability." But, under the proposal, they cannot if, in the sole opinion of the abortionist, killing the baby is necessary for the mother's "mental health."

Prop 3 also redefines "viability" so any newborn with an illness or disability could be deemed non-viable (even by a non-doctor) and left to die.

The proposal would also prevent the investigation of **infanticides** as "adverse action" against a "perceived pregnancy outcome."

# What Voters Need to Know About Proposal 2: the VoteSCAM

In the upcoming November election, voters will be asked to amend the Michigan Constitution to remove every last remaining safeguard against election fraud.

If adopted, the **VoteSCAM Proposal (Proposal 2)** would do all of the following:

(1) **Allow anyone to vote with no identification.**

(2) **Legalize ballot harvesting**, the practice of political operatives delivering absentee ballots to clerks. Nothing could prevent them from steaming open the envelope and altering the ballots in any way they choose – or just throwing them away – without being detected.

(3) **Allow private entities to fund electioneering operations** under color of government.

(4) **Require that polls be open for at least ten days**, making it totally impractical for citizens to perform the essential functions of poll watching and poll challenging.

(5) **Require ballot dropboxes in every municipality**, allowing ballot harvesters and traffickers to deposited their manipulated ballots without detection.

(6) **Dismantle the audit process** by prohibiting opposing parties from participating and ensuring the process is fair.

## Confessions of a voter fraud: I was a master at fixing mail-in ballots

[...] The ballot has no specific security features — like a stamp or a watermark — so the insider said he would just make his own ballots.

"I just put [the ballot] through the copy machine and it comes out the same way," the insider said.

But the return envelopes are "more secure than the ballot. You could never recreate the envelope," he said. So they had to be collected from real voters.

He would have his operatives fan out, going house to house, convincing voters to let them mail completed ballots on their behalf as a public service. The fraudster and his minions would then take the sealed envelopes home and hold them over boiling water.

"You have to steam it to loosen the glue," said the insider.

He then would remove the real ballot, place the counterfeit ballot inside the signed certificate, and reseal the envelope. "Five minutes per ballot, tops..."
